AN ORDINANCE TO AMEND ORDINANCE NUMBER 2022-04-14-A

WHEREAS, the Finance Committee of the Fayette County Board determined the amount of money estimated and deemed necessary to meet and defray the legal liabilities and necessary expenses that were anticipated to be incurred from December 1, 2021 through November 30, 2022, and listed their specific detailed general fund budget and special fund budgets by itemizing county expenditures for the fiscal year ending November 30, 2022; and

WHEREAS, the Fayette County Board concurred with the Finance Committee findings and adopted the Fayette County, Illinois Budget Appropriations and Tax Levy Ordinance for the fiscal year ending November 30, 2022, and

WHEREAS, since the adoption of the Budget Appropriation and Tax Levy Ordinance for the fiscal year ending November 30, 2022 the county in normal course of business has identified required clerical edits and necessary realignments; and

WHEREAS, the County Board sees fit to amend the previously approved Budget Appropriation parts of the Budget Appropriation and Tax Levy Ordinance.


NOW THEREFORE, BE IT ORDAINED by the Fayette County Board that the following recommended budget amendments to the Probation Victim Impact fund are hereby adopted for the fiscal year ending November 30, 2022.

RESOLUTION


WHEREAS; a request for **County Bridge Funds** for the purpose of replacing culverts, on T.R. 279 (2100 Ave) over an unnamed Creek, in Shafter Township, located approximately two (2) miles north of Shafter, in accordance with Section 5-501, Chapter 121 of the Illinois Statutes has been filed; and

WHEREAS; the general assembly of the State of Illinois, amended Section 5-602 of the Road and Bridge Laws of Illinois, providing that any county for the purpose of administering Section 5-501, 5-502, 5-503 and 5-504 of this code and having less than 1,000,000 inhabitants may levy an additional annual tax not exceeding 0.05 percent of all the taxable property in such county, as equalized or assessed by the Department of Revenue, which tax shall be in addition to all other county taxes and shall be in excess of any other rate limitation; and

WHEREAS; Shafter Township has petitioned the Fayette County Board for aid in replacing the culverts under Section 5-501 and 6-508, Chapter 121 of the Illinois Statutes as specified in the petition on file with the Fayette County Clerk; and


NOW, THEREFORE BE IT RESOLVED; that the County Board shall appropriate sufficient funds to pay one-half the expense, estimated to be \$12,000, to replace the requested culvert; and

BE IT FINALLY RESOLVED; that the funds necessary to furnish the county bridge aid required in the construction of the above-described culvert shall be obtained from the **County Bridge Fund**.

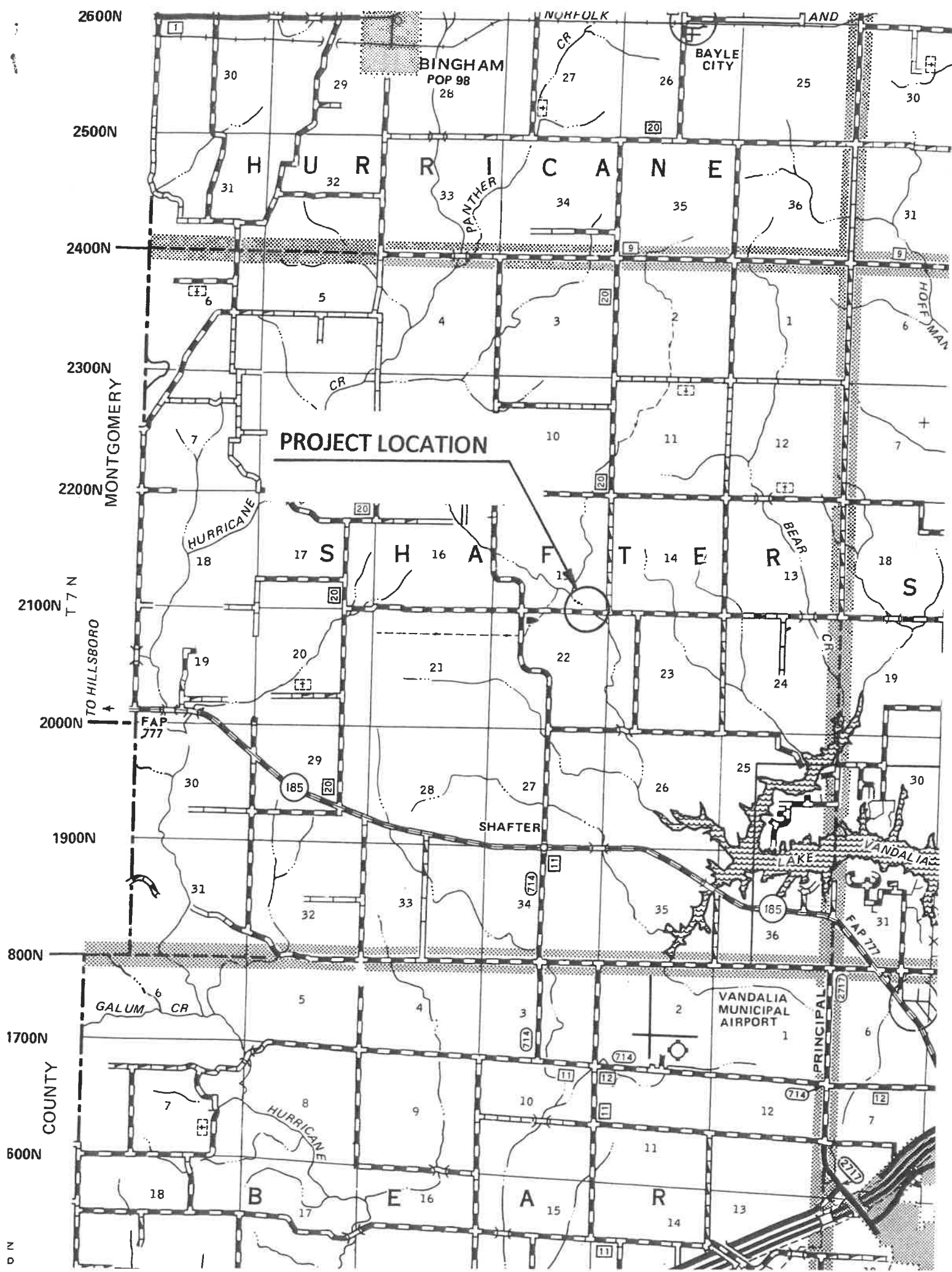

RESOLUTION ESTABLISHING THE MILEAGE REIMBURSEMENT FOR
FAYETTE COUNTY

WHEREAS, Fayette County, Illinois (the "County"), has heretofore been duly organized and is now operating as a county under the provisions of the Illinois Counties Code, and all laws amendatory thereof and supplementary thereto (the "Code"); and

WHEREAS, the Illinois Legislature has enacted the Local Government Travel Expense Control Act (Public Act 99-0604); and,

WHEREAS, Fayette County provides mileage reimbursement to Fayette County elected officials and employees who use their privately owned vehicles in the performance of official duties; and


WHEREAS, the cost of fuel and services related to the use of privately owned vehicles has increased; and

WHEREAS, the Internal Revenue service fixes the standard mileage rate for business on the basis of an annual study of the fixed and variable costs of operating an automobile; and

WHEREAS, the County Board sees fit to amend the previously approved mileage reimbursement rate.

NOW THEREFORE, BE IT Resolved by the Fayette County Board that the mileage reimbursement rate will be reimbursed at the Internal Revenue Service rate of the current year.
