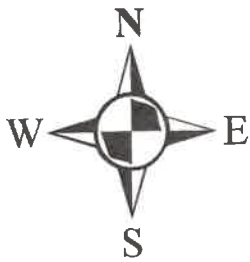

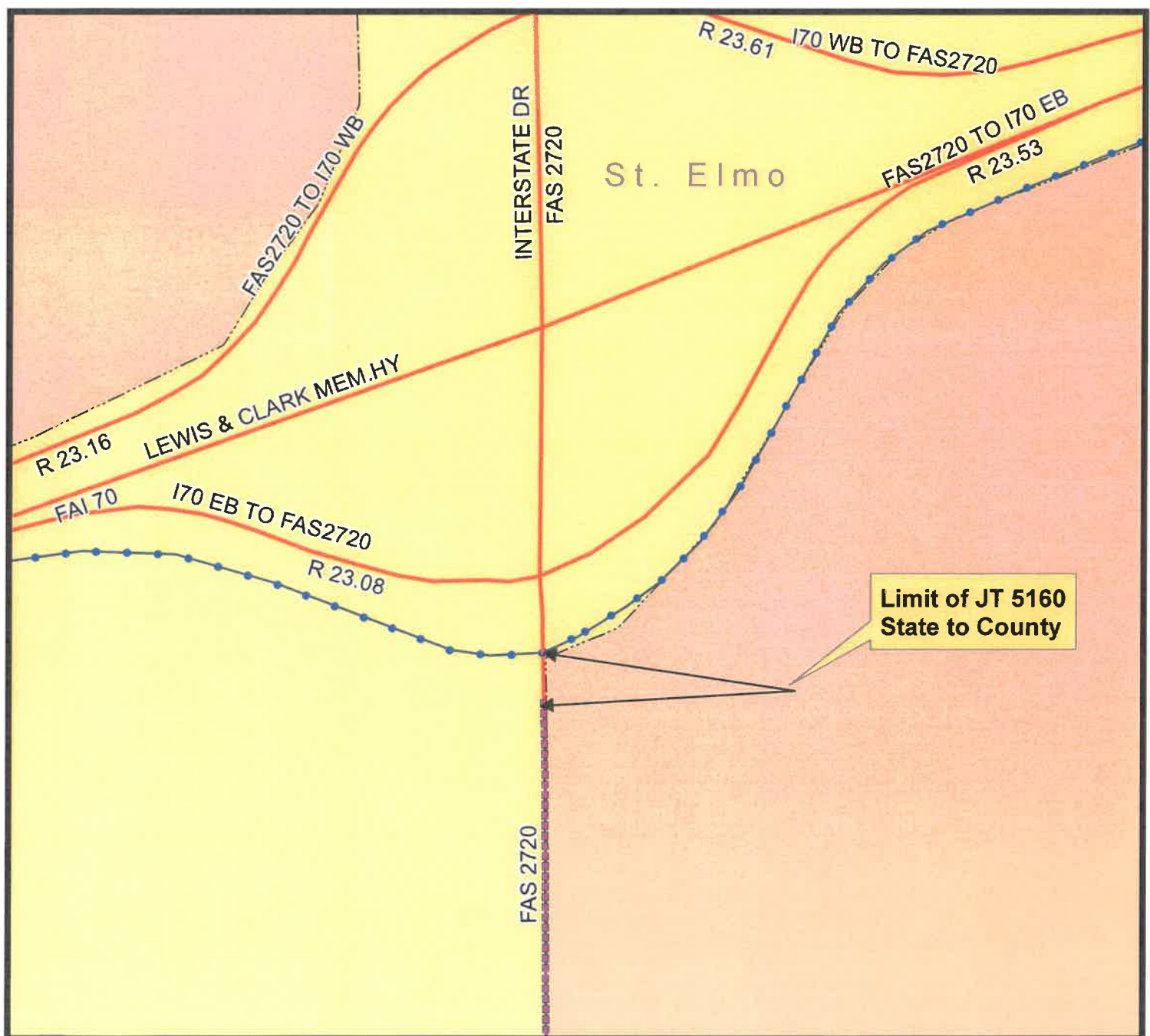

Dear Ms. Barker:

This letter will document the intent of Fayette County and the Illinois Department of Transportation (IDOT) to enter into a future agreement.

Fayette County will agree to accept the future jurisdiction and maintenance responsibilities of 0.02 miles of FAS 2720, which will not include the land rights. The limits include Interstate Drive/CH7 (FAS 2720) from the south edge of pavement of I-70 Frontage Road (Frontage Road 23.340/22.500) southerly 0.02 miles in its entirety (See the attached Location Map).

Upon receipt of this signed Letter of Intent, the department will draft a County/State agreement.

Following the execution of the County/State agreement, the jurisdictional transfer will take place 21 days following execution of the agreement.


