WHEREAS, Mary Whipple, has paid \$1,208.32 for the full amount of taxes involved and a request for surrender of the tax sale certificate has been presented to the County board and at the same time it having been determined that the County shall receive \$572.71 as a return for its Certificate(s) of Purchase. The County Clerk shall receive \$99.00 for cancellation of Certificate(s) and to reimburse the revolving account the charges advanced from this account. Mary Whipple shall receive \$40.00 for overpayment. The remainder is the amount due the Agent under his contract for services.

RESOLUTION FOR PARTICIPATION IN STATE OF ILLINOIS FEDERAL SURPLUS PROPERTY/GENERAL SERVICES ADMINISTRATION PROGRAM

WHEREAS, the Fayette County Emergency Management Agency (hereinafter referred to as "Fayette County EMA") has limited fiscal resources available for the procurement of heavy-duty equipment, vehicles, commodities, and other property; and

WHEREAS, the Fayette County EMA wishes to participate in the State of Illinois Federal Surplus Property/General Services Administration Program; and

WHEREAS, the Fayette County EMA agrees to the following terms and conditions as set for by this Program: to use the surplus property only in the official program which it represents; and upon receipt, agrees to place the surplus property into use within one year; and it agrees that the property shall be used for a period of one year (certain items, eighteen months); that it agrees it will not sell, loan, trade or tear down the property without written consent from the State of Illinois; and

WHEREAS, the Fayette County EMA understands that surplus property must be used in an authorized program and that personal use or non-use of surplus property is not allowed;

NOW BE IT RESOLVED, that we, the Fayette County Board, do hereby consent and decree that the Fayette County EMA is authorized to participate in the State of Illinois Federal Surplus Property/General Services Administration Program.
